#### Budget

DDA Budget and Balance not available. November was \$142,000.

## DDA

Additional forms and reports are required to attain PA-57 compliance. To become compliant there is a process. Compliance is necessary to receive NLEA funding.

DDA must report in forms all "inter-village" transfer of funds, such as from DDA to Fire Department. Since 2018, PA-57 requires DDA must declare to the Michigan treasury on funds received and spent.

Could let the DDA expire rather than correct the compliance.

Jim G. contact Travis at the State of Michigan. Will will contact the Emmet County Treasurer.

NLEA will work with Will and Jim on TIF once DDA is in compliance.

Consensus is to move forward with the DDA TIF and restore the compliance.

## **PFAS**

Posen and other villages have had to get a water system. Posen is similar in size to Pellston.

Looking at \$50,000 grant from EGLE for looking at a water system.

Jim: It looks like we will end up in with a Water System, and possibly a sewer.

Test wells were drilled down to 100 feet NE of Airport.

Looking for possible location of water source. However, they found PFAS.

EGLE pumped Plume-Stop in wells on airport to hold the plume in place. Now this is showing up in water testing so plume-stop clay is being washed away. Liquid Activated Carbon .

More household testing planned.

OHM study should conclude in 2024, possibly this summer.

By law people are not required to sign up for water. Must provide incentives. No new wells will be approved. Incentive is to sign up when it is installed.

Why wouldn't the 3M and other \$10B settlements pay for the replacement service instead of residents? Unknown.

Good cooperation with Emmet county and EGLE.
