### **Budget**

About \$8,000 expenses in December Approximately \$143,000 in balance.

#### Introduction to new Members

The DDA has been in existence for about 20 years and NEMCOG is contracted to create a new TIF Plan for the DDA.

The DDA is subordinate to the Council and the Village Council approves what the DDA does. Generally the council approves of the DDA motions.

Meet every first Tuesday, often skip 4th of July and conflicting holiday weeks.

Some participation on village events including music events, summer picnic, sledding party.

DDA funds fire department, park upgrades, streets and streetlights, and other projects to improve downtown.

DDA is working on a trailhead. The DDA works with the NLEA for community development projects. Project was approved but COVID and rising costs have delayed the project. Portion of DDA funding is reserved for the Trailhead.

TIF is Tax increment financing. As taxes go up, the DDA receives funding from the businesses in the DDA district.

Upcoming responsibility of the DDA will be to help onboard citizens to the new water system. Mediate council, airport, county, state, federal and other stakeholders for PFAS relief. May need a vote. Need to educate the community on the solution.

### **PFAS**

There will be a village meeting in the Spring 2025.

Looking at a \$40M loan (forgivable) to provide a water system.

Cost to taxpayers is nothing at the beginning. Will need to pay later.

No new well permits, so eventually will need to provide a water system.

Water system will encourage economic investment.
